

**GRAND TETON MUSIC FESTIVAL/LEXUS CHARITY RAFFLE
OFFICIAL RULES**

**THIS RAFFLE IS OPEN ONLY TO ATTENDEES OF THE GRAND TETON MUSIC
FESTIVAL. YOU MUST BE PRESENT AT THE DRAWING IN ORDER TO WIN.**

Charitable Purpose: All proceeds from the raffle will be put towards charitable endeavors relating to classical music. Money given to Grand Teton Music Festival, a registered 501(c)(3) organization, is not tax deductible if exchanged for a raffle ticket. The Grand Teton Music Festival/Lexus Charity Raffle (the "Raffle") is operated pursuant to Wyoming laws §§ 6-7-101 *et seq.*

1. Eligibility: The Raffle is open only to legal residents of the 48 contiguous United States and the District of Columbia (void in Alaska and Hawaii) who are at least nineteen (19) years old at the time of entry. Employees of Toyota Motor Sales, USA, Inc.; Grand Teton Music Festival; ePrize, LLC; and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to applicable federal law, as well as state and local laws and regulations of the State of Wyoming. Void where prohibited. Participation in this Raffle constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Raffle. Winning the prize is contingent upon fulfilling all requirements set forth herein.

2. Sponsor: Lexus, a division of Toyota Motor Sales, USA, Inc., 19001 South Western Avenue, Torrance, CA 90501. **Administrator:** ePrize, LLC, One ePrize Drive, Pleasant Ridge, MI 48069. **Charitable Organization:** Grand Teton Music Festival, a registered 501(c)(3) organization, 4015 W. Lake Creek Drive, #1, Wilson, Wyoming 83014.

3. Timing: The sale of Raffle tickets begins on April 21, 2008 and ends on June 28, 2008 (the "Promotion Period").

4. How to Buy Raffle Tickets: Participants may purchase a raffle ticket for \$500.00 (USD) each, or in a set of five (5) tickets for \$2,000.00 (USD). Entrant may pay with, and Sponsor will accept, cash, check, money order, Visa, MasterCard, American Express, and Discover credit cards. Entrants may purchase as many tickets as is desired, but no more than two hundred (200) tickets will be sold.

5. Raffle: Administrator is an independent judging organization whose decisions as to the administration and operation of the Raffle and the selection of the potential winner are final and binding in all matters. Charitable Organization will randomly select the potential Raffle winner by selecting one (1) raffle ticket at the close of the Promotion Period. The potential winner will be notified immediately by public address announcement. The potential winner will have one (1) hour to claim the prize. In order to claim the prize, the potential winner must sign and return to Charitable Organization an Affidavit of Eligibility/Liability & Publicity Release ("Affidavit"), and provide proof of ability to drive (valid state-issued driver's license). **MUST BE PRESENT TO WIN.** If the potential winner is not present at the Festival during the selection process, or does not claim the prize within the stated time period, he/she will be disqualified and will forfeit the prize. In the event that the potential winner is disqualified for any reason, Charitable Organization will award the prize to an alternate potential winner by random drawing from among all remaining lottery tickets. If an alternate potential winner is chosen, that potential winner will be contacted directly via telephone or e-mail (Charitable Organizations discretion). Once notified, the potential

alternate winner will be required to complete the Affidavit in person at Sponsor's place of business. The winner who meets all of the eligibility requirements, is verified, and has fully complied with these Official Rules will be given the Prize. Prize must be ordered from a participating Lexus dealership, and will be delivered to that dealership approximately twenty six (26) weeks after prize is ordered. Delivery can be made to any participating Lexus dealership within in 48 contiguous United States.

6. Prize: One (1) new Lexus LX 570 (2008 model year). Sponsor will determine all features, including, but not limited to, exterior and interior style and color, options, and accessories. All features or upgrades not included by Sponsor will be allowed only if permitted by Sponsor and paid for by winner. The winner must be a licensed driver and hold a valid driver's license in his/her state of residence and will be required to provide proof of insurance in order to take delivery. If winner does not provide proof of a valid driver's license and proof of insurance prior to delivery, winner forfeits prize. Winner is responsible for all taxes, including but not limited to federal, state and local taxes, title, license, registration, dealer preparation costs, delivery or destination fees, auto insurance, gasoline, and other requirements and expenses and fees associated with the acceptance and use of prize. Winner must take delivery of the prize from the automobile dealership designated by winner, subject to Sponsor's approval, within thirty (30) days of written notification of delivery. Sponsor shall not be responsible for delays in delivery of the prize vehicle. Sponsor, however, shall use all reasonable efforts, subject to availability, to deliver the prize vehicle within twenty six (26) weeks after ordering. Approximate Retail Value of Lexus LX 570: \$73,800.

The prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the prize should become unavailable for any reason. Odds of winning the prize depend on the number of eligible raffle tickets sold during the Promotion Period, but will not exceed 199 to 1.

7. Release: By receipt of the prize, winner agrees to release and hold harmless Sponsor, Administrator, the Charitable Organization, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Raffle or receipt or use or misuse of the prize.

8. Publicity: Except where prohibited, participation in the Raffle constitutes winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration.

9. General Conditions: Administrator reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the raffle ticket sale process or the operation of the Raffle or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Raffle may be a violation of criminal and civil law, and, should such an attempt be made, Administrator reserves the right to seek damages from any such person to the fullest extent permitted by law. Administrator's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants or printing errors; (2) unauthorized human intervention in any part of the entry process or the Raffle; or (3) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Raffle or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is the purchase of another raffle ticket. No more than the stated number of prizes will be awarded. Errors in the production, seeding, printing, sales, or distribution of the raffle tickets will not result in Sponsor drawing more than one (1) winner, or giving away or raffling off more one (1) prize, as set forth in these Official Rules.

11. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of Wyoming or the appropriate Michigan State Court located in Teton County, Wyoming; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Raffle, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant Administrator and Sponsor in connection with the Raffle, shall be governed by, and construed in accordance with, the laws of the State of Wyoming without giving effect to any choice of law or conflict of law rules (whether of the State of Wyoming or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Wyoming.
